

LEGAL NOTICE AND CONDITIONS OF USE

1. Website owner

The present website <https://www.zytec.es> (hereinafter, the "Website") is owned by ZYTEC EUROPA, S.L. (hereinafter, "ZYTEC"), a company incorporated under Spanish law, with registered office at Calle Pollensa, 4, 2nd floor, office 11, 28290, Las Rozas (MADRID) with CIF B85212405 and registered in the Mercantile Register of MADRID, Volume 24906, Page 171, Section 8, Page M-448418, Book 0, Registration 1.

2. Object, scope and duration

This Legal Notice regulates the use of the Website, as well as its access, navigation and, in general, the relationship of the owner of the Website with any person who accesses it (hereinafter referred to individually as the "User" or collectively as the "Users").

The Website provides Users with general information about ZYTEC and its activities (hereinafter, the "Content"), all in accordance with this Legal Notice. Being a professional page, its content is not aimed at Users who are minors.

Notwithstanding the foregoing, access to certain content or services that may be provided in the future may be subject to compliance with particular conditions that, as the case may be, will replace, complete and / or modify these general conditions and, in case of contradiction with these, they will prevail.

ZYTEC reserves the right to modify, at any time and without prior notice, the presentation, configuration and content of the Website or the conditions required for its access and / or use, as well as interrupting, suspending or terminating access to the content of the Website, with no possibility for the User to demand any compensation.

The temporary validity of this Legal Notice coincides, therefore, with the time of its exposure, until it is totally or partially modified, at which time the new legal notice made available to Users in this Site will become valid. Web.

The access, navigation and use of the Website by a User implies the express and unreserved acceptance of all the terms of this Legal Notice and any particular conditions, having the same validity and efficacy as any contract signed in writing.

3. Access

The use of the Website will be free, without prejudice to the cost of connection through the corresponding telecommunications network for the User to have access to it.

ZYTEC is not responsible for any damages or losses of any kind caused to the User that result in failures or disconnections in the telecommunications networks that produce the suspension, cancellation or interruption of access to the Website.

Those who access the Website must observe the applicable legislation, the ethical codes and the Conditions of Use of the Website scrupulously.

The excessive or abusive use of the Website may result in the denial of access to it. - h. Failure to comply with the technical requirements or specifications established for access to the Website.
- i. Promote, carry out, support or encourage actions contrary to free competition or that constitute unfair competition.
